[Overview and purpose of the course]							
<p>This course will introduce students to the International History of East Asia from the First Opium War in 1839 to the end of the Second World War in 1945. Students will understand how global connections affected the development of the history of East Asia from the period beginning with the Opium Wars and ending with Japan ' s defeat in the Second World War. The lecture series as outlined below will discuss how commodities such as opium played a role in initially ' opening up ' East Asia to modern trade and how this helped to create two opposing modernising trends in the Japanese Empire and China. It will discuss the global flow of ideas such as the racist ' Yellow Peril ' doctrine, the Pan-Asian movement, feminism, communism and imperialism. The course will throughout focus on international cooperation and the transfer of ideas not just within East Asia but with also with the wider world. Japan ' s interaction with the League of Nations and the Kuomintang ' s flirtations with the Comintern dominated the 1920s. It will then analyse the global context in which the Second-Sino Japanese War broke out in which these two opposing modernising forces clashed.</p>

Students will gain a knowledge of the international relations of East Asia and be able to demonstrate this through a written essay and class discussion.
