| <p>This course offers a guided introduction to jurisprudence-the philosophical study of law. Designed for students without prior legal background, the course explores foundational questions such as: What is law? What makes law legitimate? How does law relate to morality, justice, power, freedom, and community? Combining classical theories with contemporary perspectives, we will examine how major legal thinkers have understood the nature of law and its role in society. The course also engages with pressing modern challenges, such as legal interpretation in complex societies, the impact of technology, and the tension between individual rights and collective values.</p> <p>Students are encouraged to approach these themes not by memorising fixed answers, but by critically engaging with diverse ideas and developing their own perspectives. From Week 2 to Week 14, each session will follow a consistent structure designed to support both reflection and progressive understanding. The class will begin with a 5-minute review of the previous week's core concepts, followed by 15 minutes of open discussion and 15 minutes of group sharing. The remaining 55 minutes will be devoted to lecture-based input. The lecture content of each week will provide the foundational knowledge for the discussion in the following session.

\*To support students' learning and in consideration of the actual composition of the class, the instructor reserves the right to make minor adjustments to the weekly schedule as needed.

### [履修要件]

Students are expected to have the ability to learn and participate in discussions in English. No prior legal or disciplinary knowledge is required. An open mind and a willingness to engage with diverse perspectives are essential. An interest in abstract and theoretical thinking is also important for meaningful participation in this course.

### [成績評価の方法・観点]

The final grade will be based on class participation (30%) and a final exam (70%).

Class participation will be evaluated through students' engagement in group discussions and their contributions to in-class sharing activities. There will be no written assignments required outside of class. However, in-class tasks may vary depending on the weekly topic and may include short written responses, group exercises, or thematic reflections.

The final exam will consist of both multiple-choice questions, which assess students' understanding of foundational course content, and analytical questions, which evaluate the ability to think critically based on the knowledge learned.

Rather than following a single textbook, this course will provide handouts and reading materials aligned with the weekly topics. These will include required readings as well as optional supplementary materials for further exploration.
